Official Sweepstakes Rules and Regulations

2023 Big Green Egg in an intEGGrated Nest Package Sweepstakes

Summary: Open a new personal checking account with a Discover® debit card at Planters First Bank from November 1, 2023, to Friday, November 30, 2023, and you will be entered into a drawing to win Big Green Egg in an intEGGrated Nest Package (\$2000 Value). One prize will be awarded at our new Warner Robins Banking Center located at 361 S. Houston Lake Road, Warner Robins, GA 31088. An entry automatically occurs every time a new checking account is opened during the Sweepstakes Entry Period. There is a limit of one entry per person (for personal accounts with a Discover® debit card). A minimum deposit of \$50 is required to open a checking account; other minimums, fees, and conditions may apply depending on the type of account selected. The chances of winning the prize are based on the number of eligible entries received at our Warner Robins Banking Center located at 361 S. Houston Lake Road, Warner Robins, GA 31088. Prizes are non-transferable and may not be exchanged or redeemed for cash or credit.

Sweepstakes Entry Period: The Sweepstakes Entry Period begins at the start of business on November 1, 2023, and ends at the close of business on November 20, 2023.

Sponsor/Participating location: Planters First Bank, Warner Robins Banking Center, located at 361 S. Houston Lake Road, Warner Robins, GA 31088.

How to Enter: There are three (3) ways to enter the Sweepstakes during the Sweepstakes Entry Period.

- 1) **Automatic Entry:** One entry into the drawing automatically occurs upon opening a new personal checking account at a participating Planters First Bank location, and entries will be assigned to the drawing for the participating location where the account is opened. For personal accounts, one entry will be made jointly in the name(s) of all primary owners of the account.
- 2) **Current Personal Account Holders with Discover® Debit Card: Complete Transactions with your Planters First Bank Discover® Debit Card:** During the Promotion Period, use your Planters First Bank Discover® Debit Card to complete a card PIN or signature-based purchase (“Transaction”), and you will automatically receive one (1) entry into the applicable Monthly Entry Period drawing associated with the date and time of your transaction.

There is a limit of one entry per person, and mail-in entries must be sent in a postmarked, stamped envelope.

Drawings, Determination & Notification of Winner(s): Random drawing will be held on or shortly before December 8, 2023, from all entries received during the Sweepstakes Entry Period for participating location.
