- 4. How to Enter: You must be a Planter's First Bank Discover Debit card holder. There are two (2) methods of entry:
 - a. Complete Transactions with your Planters First Bank Discover® Debit Card: During the Promotion Period, use your Planters First Bank Discover® Debit Card to complete a card PIN or signature-based purchase ("Transaction") and you will automatically receive one (1) entry into the applicable Monthly Entry Period drawing associated with the date and time of your transaction (see Opt-Out process below if you don't want to be included in the Sweepstakes).
